I understand that the ski/boot/binding system will not ordinarily release during use, nor is it specifically designed to release as the result of forces induced during ordinary operation and is therefore absolutely no guarantee of my safety.

In consideration of all of the above and in consideration of the equipment being rented to me at my request, **I AGREE NOT TO SUE, AND, AS SUCH, RELEASE HIDDEN VALLEY RESORT FROM ANY AND ALL LIABILITY FOR DAMAGE AND/OR INJURY TO MYSELF OR TO ANY PERSON OR PROPERTY, REGARDLESS OF ANY GROSS NEGLIGENCE, ORDINARY NEGLIGENCE, RECKLESSNESS, AND/OR CARELESSNESS ON THE PART OF HIDDEN VALLEY RESORT**, and accept for myself full and complete responsibility for any and all such damage, injury or death which may result. **I AGREE TO INDEMNIFY HIDDEN VALLEY RESORT FOR ANY AND ALL COSTS OR FEES, INCLUDING ATTORNEY'S FEES AND COSTS, ASSOCIATED WITH DEFENDING ANY CLAIM BROUGHT BY OR ON BEHALF OF THE UNDERSIGNED.**
